The Role:

- To ensure that safety and compliance standards are maintained, and any issues are addressed immediately
- Supporting the water, electric and GTM operational contracts in the South West
- Focal point for delivery of records, documentation, and trend, including fire, depot, and agent inspections
- Completion of verification inspections and audits – follow up on closure of findings/non conformances
- Supporting accident and incident investigations, and promoting good quality reporting and closure
- Completing and encouraging hazard reports
- Completing a weekly and monthly report on achievements and issues identified
- Communicating and driving an efficient close out of corrective actions raised by the Compliance Department and external auditors
- Compiling Accident/Incident Stats for the contracts your support and attending client meetings
- Working with the wider operational team to maintain strong relationships and improving processes/systems where possible
- Drive the correct and safe behaviors out on site and within the office
- Supporting the Competence Assessment process
- Assist the Quality Manager with accreditations and provide support where required (ISO45001)
