Key responsibilities

You will be responsible for the delivery of records, documentation, and trend, including fire, depot, and agent inspections

You will be responsible for the completion of verification inspections and audits – follow up on closure of findings/non conformances

You will support the accident and incident investigations, and promoting good quality reporting and closure

You will complete and encourage hazard reports

You will complete a weekly and monthly report on achievements and issues identified

You will communicate and driving an efficient close out of corrective actions raised by the Compliance Department and external auditors

You will compile Accident/Incident Stats for the contracts your support and attending client meetings

You will work with the wider operational team to maintain strong relationships and improving processes/systems where possible

You will drive the correct and safe behaviours out on site and within the office

You will support the Competence Assessment process

You will assist the Quality Manager with accreditations and provide support where required (ISO45001)
